

# ZELY NOTE TERMS OF SERVICE

Last Updated: October 10, 2025

These Terms of Service ("Terms") govern your use of the Zely Note mobile application ("the App") operated by Zely Note ("the Company", "we", "our", "us"). By downloading or using the App, you agree to these Terms. If you do not agree, do not use the App.

1. **ELIGIBILITY** You must be at least 16 years of age to use Zely Note. By using the App, you represent that you meet this requirement.

2. **LICENSE** We grant you a limited, non-exclusive, non-transferable, revocable license to install and use the App solely for your personal use, subject to these Terms. You may not copy, modify, reverse engineer, distribute, or sublicense the App or any part thereof.

3. **USER CONTENT** All notes, transcriptions, and data created within Zely Note remain stored locally on your device. You retain full ownership of your content. The Company does not access, store, or transmit your content under any circumstance unless you explicitly export or share it using your device's operating system features.

4. **PRIVACY AND SECURITY** Zely Note is designed for privacy-first, offline operation. The App does not collect analytics, personal identifiers, or usage data. No third-party SDKs or tracking tools are embedded. Optional transcription via Groq Whisper is an opt-in feature with explicit user consent. For details, refer to the Privacy Policy.

5. **SUBSCRIPTIONS AND PAYMENTS** Zely Note offers optional paid features accessible through Apple's StoreKit framework. All billing, subscription management, and payment processing are handled directly by Apple. The Company does not process, store, or have access to billing information. Subscription validation occurs locally within the App, without remote servers.

6. **PROHIBITED USES** You agree not to misuse the App or attempt to access, decompile, or disrupt its operation. You may not use Zely Note in violation of applicable laws or in ways that interfere with other users' rights or privacy.

7. **TERMINATION** We reserve the right to suspend or terminate your access to the App at any time, without notice, for violation of these Terms or any applicable law. You may terminate your use at any time by uninstalling the App.

8. **DISCLAIMERS** The App is provided "as is" without warranty of any kind. We make no representation that Zely Note will be error-free, uninterrupted, or suitable for any particular purpose. You use the App at your own risk.

9. **LIMITATION OF LIABILITY** To the fullest extent permitted by law, Zely Note and its affiliates, officers, employees, or licensors shall not be liable for any indirect, incidental, or consequential damages arising from your use of the App.
